




RELATIVE INTENSITY vs. WAVELENGTH





SPATIAL DISTRIBUTION












REFLOW SOLDERING PROFILE for LEAD-FREE SMD PROCESS




 2. The maximum number of reflow soldering passes is 2 times.




REEL DIMENSION (units: mm)
